ORDER SETTING CONCURRENT CONFERENCE

The Missouri Public Service Commission is granting *Staff's Motion for a Concurrent Prehearing Conference* ("motion").¹ The motion asks for a conference to coordinate scheduling in this action with scheduling in the general rate action of Liberty Utilities.² That action is proceeding contemporaneously with this action. Staff states that the timing of the two actions is causing scheduling issues for the parties. Therefore, the Commission will grant the motion and convene a conference concurrently with the conference scheduled in the Liberty Utilities action.³

THE COMMISSION ORDERS THAT:

1. *Staff's Motion for a Concurrent Prehearing Conference* is granted.
2. A conference as described in the body of this order will be convened at 10:00 a.m. on March 13, 2014, in Room 310, Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. That building meets accessibility standards required by
