## ORDER CLOSING FILE

Staff reported<sup>1</sup> that the subject matter of this file was also before the Commission in the pending general rate action of Laclede Gas Company. Staff suggested that:

... it would be duplicative and a waste of all parties' resources (including the Commission's), as well as potentially confusing and contradictory, to address the same issue in [File] No. GR-2017-0216, rather than in this case."<sup>2</sup>

For that reason, the Commission considered consolidating this action with the general rate action, but first sought the parties' input.<sup>3</sup>

Staff responded that other issues in this case are also pending before the Commission, in File No. GO-2017-0223.<sup>4</sup> Staff suggests that the more efficient disposition is simply to close this file. Staff also represents that all parties agree.

Therefore, the Commission concludes that Staff has shown cause why the Commission should not consolidate this action with the rate case, and will close this file.
