## **INITIAL CUSTOMER NOTICE**

#### Dear Customer:

On December 2, 2013, Hickory Hills Water & Sewer Company (Company) submitted a request for increases in its annual water and sewer operating revenues to the Missouri Public Service Commission (Commission). The reasons for the increases are to cover increases in expenses and/or investments in the Company's facilities.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual sewer operating revenues of \$6,248 (approximately 25.00%) and an increase in its annual water operating revenues of \$4,525 (approximately 25.00%), respectively. At the end of this notice is a table that compares the Company's current residential customer rates and the proposed residential rates at 6,000 gallons usage.
