ORDER APPROVING INTERIM RATES

)

Issue Date: October 27, 2010 Effective Date: November 1, 2010

Syllabus: This order approves Atmos Gas Corporation's (hereafter "Atmos") tariff that increases the Purchased Gas Adjustment rate.

On October 15, Atmos filed a tariff sheet that bears an effective date of November 1.¹ For the Atmos West Area – Butler District, the PGA factor will increase \$0.07169 per Ccf. For the Atmos West Area – Rich Hill/ Hume District, the PGA factor will increase \$0.07929 per Ccf. For the Northeast Area, the PGA factor will increase \$0.22549 per Ccf. For the Kirksville Area, the PGA factor will increase \$0.11869 per Ccf. For the Southeast Area, the PGA factor will increase \$0.20109 per Ccf.

On October 22, the Staff of the Commission filed its Recommendation. Staff recommends that the Commission approve the proposed tariff sheet for service on and after November 1, as an interim rate, subject to refund.

Staff states that Atmos' proposed PGA factor changes were calculated in conformity with its PGA clause. Staff further states that Atmos' PGA clause allows for 10 business days' notice for filings reflecting PGA changes, and that good cause exists to approve the proposed tariff sheets on less than 30 days' notice. Staff recommends that the Commission approve the tariff sheets to become effective November 1, on an interim basis,

subject to refund, pending a final Commission decision in this case and in Atmos' other Actual Cost Adjustment cases, which are: GR-2009-0417 and GR-2008-0364.

The Commission has reviewed the proposed tariff sheet and Staff's Recommendation. The Commission finds that the tariff sheet conforms to the company's Commission-approved PGA clause and is, therefore, reasonable. After considering Staff's recommendation, and for good cause shown pursuant to Section 393.140(11), RSMo 2000, the Commission concludes that the proposed tariff sheet should be approved to become effective on and after the requested effective date of November 1, on an interim basis, subject to refund.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheet filed on October 15, 2010, by Atmos Gas Corporation, is approved on an interim basis, subject to refund, for service rendered on and after November 1, 2010. The tariff sheet approved is:

2. This order shall become effective on November 1, 2010.
