## STAFF RECOMMENDATION REGARDING THE EMPIRE DISTRICT GAS COMPANY'S ACTUAL COST ADJUSTMENT FOR 2011-2012

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its recommendation, states as follows:

- 1. On October 31, 2012, Empire District Gas Company (Empire or Company) filed its Actual Cost Adjustment (ACA) for the 2011-2012 annual period for rates to become effective November 14, 2012.
- 2. The Procurement Analysis Unit (Staff) has reviewed the Company's ACA filing and submits its recommendation as explained in Staff's Memorandum attached hereto as Appendix A. Staff's review included a comparison of billed revenue recovery with actual gas costs to determine whether there exists an over-recovery or underrecovery of the ACA balance.
- 3. Staff's review identified accounting adjustments to the Company's filed ACA balances. Positive adjustments represent an increase in gas costs to consumers and negative or "bracketed" adjustments represent a decrease or reduction in gas costs to consumers. The accounting adjustments are summarized by system as follows:

• South – Firm \$263,939

• North – Firm \$(101,636)

• NW – Firm \$(186,666))

The total net Company adjustment is \$(24,363) which represents a decrease in gas costs to consumers. These adjustments are shown in greater detail in the "Executive Summary" section on page 2 of Staff's Memorandum and in the "Recommendations" section on page 8.

- 4. Staff made no adjustments related to reliability analysis, gas supply planning, and hedging. However, the Staff makes recommendations in these areas in their respective sections of the memorandum (Sections III and IV).
- 5. Staff suggests the Commission order Empire to respond to the Staff's recommendations, summarized in Section V. "Recommendations" of the memorandum, within 45 days of this filing.

WHEREFORE, based on the reasons stated above and explained in Staff's Memorandum, the Staff recommends the Commission order Empire to respond to Staff's Recommendation within 45 days.
