ORDER GRANTING JOINT REQUEST FOR EXTENSION

On December 22, 2021, Spire Missouri Inc. d/b/a Spire submitted an application requesting financing authorization in the amount of \$800 million through December 2024, subject to all of the terms and conditions approved by the Commission in File No. GF-2020-0334.

The Commission directed the Staff of the Commission (Staff) to provide its recommendation or a request for an extension of time on or before January 24, 2022. On January 19, 2022, Staff requested an extension of time due to outstanding data requests. Staff reports that all parties, including the Office of the Public Counsel, conferred and reached an agreement to extend the deadline for the Staff recommendation to January 31, 2022.

Due to the impact the additional information may have on Staff's report, the Commission finds the joint extension request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file its recommendation on or before January 31, 2022.
2. This order shall be effective when issued.
