ORDER DIRECTING A STATUS REPORT

On April 21, 2022, the Commission granted SNGMO's request for its parent company, Summit LDC Holdings, LLC to issue indebtedness secured by a pledge of SNGMO's capital stock. On May 4, 2022, SNGMO filed a notice concerning the timing of its transaction, informing the Commission that because of a delay in receiving approval from another jurisdiction it was unable to issue the indebtedness by May 6, 2022, as contemplated. SNGMO stated that the existing credit revolver was being extended for 90 days under its existing terms to provide additional time to issue the indebtedness. More than 90 days have passed since May 4, 2022. Accordingly, the Commission will order the SNGMO to file status report.

THE COMMISSION ORDERS THAT:

1. SNGMO shall file a status report informing the Commission of the status of this financing transaction no later than August 17, 2022.
2. This order is effective when issued.
