1 PROCEEDINGS 2 JUDGE WOODRUFF: Good morning, everyone. Welcome to the preliminaries for the hearing today. This 3 is Case No. ER-2005-0436, as well as HR-2005-0450. My 4 5 name is Judge Woodruff. I'll be the presiding judge 6 today. Also want to introduce you to the person on my 7 left here. This is Steve Reed, our newest judge, and 8 he'll be assisting me on this case, and you may see him on 9 the bench once or twice during the next two and a half 10 weeks. 11 Let's start by taking entries of 12 appearance. We'll begin with Aquila. 13 MR. SWEARENGEN: Thank you, Judge. Let the 14 record show the appearance of James C. Swearengen, Paul 15 Boudreau, Dean Cooper and Janet Wheeler, Brydon, 16 Swearengen & England. Our address is 312 East Capitol 17 Avenue, Jefferson City, Missouri. We're appearing on behalf of Aquila.
