**PROPOSED AMENDMENT TO PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), and for its Proposed Amendment to Procedural Schedule states:

1. In its Order Directing Notice, Suspending Tariff, Setting Hearings, and Directing Filings ("Order"), the Commission reserved the dates of October 20, 2008 through October 24, 2008, and October 27, 2008 through October 31, 2008 for the Hearing in this matter.

2. Due to the filing of two other major rate cases, Missouri American Water, Case No. WR-2008-0311, and AmerenUE, Case No. ER-2008-0318, shortly after the filing of this case, the Commission has been able to afford limited flexibility in allocating hearing dates among the three cases.

3. Believing eight days to be sufficient for the hearing of HR-2008-0300, and in an effort to facilitate a more workable procedural schedule in Case No. WR-2008-0311, the Staff, on behalf of all parties to HR-2008-0300, requests the amendment of the HR-2008-0300 Procedural Schedule to no longer include the days October 30, 2008 and October 31, 2008.

4. Undersigned counsel has discussed this matter with counsel for Trigen-Kansas City Energy Corporation, Kansas City Power & Light Company, County of Jackson, City of Kansas City, and the Office of Public Counsel, who indicated agreement with this proposed amendment.

**WHEREFORE**, the Staff of the Missouri Public Service Commission requests the amendment of the Procedural Schedule to reflect a revised Hearing Schedule of October 20, 2008 through October 24, 2008, and October 27, 2008 through October 29, 2008.
