**ORDER FINDING GOOD CAUSE FOR TARIFF TO BECOME**  
**EFFECTIVE ON LESS THAN THIRTY DAYS' NOTICE**

On October 14, 2005, Fidelity Natural Gas, Inc., filed a tariff sheet that reflected scheduled changes in Fidelity's Purchased Gas Adjustment (PGA) factors as the result of estimated changes in the cost of natural gas for the upcoming winter season. That tariff carried an effective date of November 1. The Commission took no action to suspend or reject the tariff so it went into effect on November 1 by operation of law.

The Recommendation and Memorandum filed on October 26 by the Staff of the Commission stated that the PGA clause in Fidelity's tariff allows for ten business days' notice for filings reflecting PGA changes and that good cause exists to approve the proposed tariff sheet on less than thirty days' notice.

The Commission concurs with Staff that Fidelity showed good cause to allow the proposed PGA tariff to go into effect on less than thirty days' notice, as permitted by Section 393.140(11), RSMo 2000. That result is consistent with Fidelity's approved tariff and is consistent with the public interest in that Fidelity's tariff simply changes the numbers

in a previously approved formula used to determine the prices to be passed through to consumers for natural gas that is priced at market rates pursuant to federal law.

**IT IS THEREFORE ORDERED:**

1. That the Commission finds that Fidelity Natural Gas, Inc., established good cause to allow its PGA tariff filing to go into effect on less than thirty days notice. The tariff sheet that went into effect is:

2. That this order shall become effective on November 3, 2005.
