Dear Secretary Bose:

On September 14, 2021, the Federal Energy Regulatory Commission (“FERC” or “Commission”) issued an Order Issuing Temporary Certificate (“Temporary Certificate Order”) in the above referenced proceeding,<sup>1</sup> which granted Spire STL Pipeline LLC (“Spire STL”) a temporary certificate of public convenience and necessity, pursuant to section 7(c)(1)(B) of the Natural Gas Act (“Temporary Certificate”),<sup>2</sup> to continue to operate the facilities authorized by the Commission in Docket Nos. CP17-40-000 and CP17-40-001 that are currently in service, under the terms, conditions, and authorizations previously issued, including the approved tariff.<sup>3</sup>

Pursuant to 18 C.F.R. § 157.20(a) (2021) and Ordering Paragraph (B) of the Temporary Certificate Order, Spire STL hereby accepts the Temporary Certificate. Spire STL also acknowledges as a condition of accepting the Temporary Certificate, that while Spire STL cannot engage in any construction, Spire STL must continue “all restoration activities along the project right-of-way.”<sup>4</sup> Spire STL submits this certificate acceptance without prejudice to its rights, pursuant to the Natural Gas Act and the Commission’s regulations, to seek clarification or to request rehearing of the Temporary Certificate Order.

Spire STL appreciates the efforts of the Commission and the Commission’s Staff in issuing the Temporary Certificate Order.
