ORDER APPROVING TARIFF IN COMPLIANCE
WITH COMMISSION ORDER

On July 19, 2007, the Commission issued its order approving a Unanimous Stipulation and Agreement regarding Laclede Gas Company's rate case, GR-2007-0208, *et al.* On October 28, 2008, Laclede filed tariff sheets (Tariff File No. JG-2009-0299) to implement two energy efficiency programs, the Residential High Efficiency Rebate Program and the Commercial and Industrial (C/I) Rebate Program, developed pursuant to paragraph 20 of the Stipulation. The tariff sheets apply to all general service residential, commercial, and industrial customers in Laclede's Missouri service divisions, and bear an effective date of November 28, 2008. Laclede filed substitute tariff sheets on November 12, 2008.

On November 19, 2008, the Commission's Staff filed its recommendation. Staff has reviewed Laclede's tariff filing and is of the opinion that it complies with the Commission's order and the Unanimous Stipulation and Agreement. Staff recommends that the Commission approve the tariff sheets as substituted.

The Commission has reviewed Laclede's tariff and the Staff's verified recommendation. The Commission concludes that the submitted compliance tariff, as

substituted, is consistent with the Unanimous Stipulation and Agreement and with the Commission's order approving that Stipulation, and shall therefore be approved.

THE COMMISSION ORDERS THAT:

1. Tariff File No. JG-2009-0299, filed by Laclede Gas Company on October 8, 2008, is approved as substituted to become effective on November 28, 2008. The tariff sheets approved are:
