## ORDER GRANTING MOTION TO ACCEPT STAFF'S MEMORANDUM AND DIRECTING FILING OF STATUS REPORT

On December 29, 2009, the Staff of the Commission filed its memorandum concerning AmerenUE's 2007-2008 Actual Cost Adjustment (ACA) filing, and a motion to leave this case open pending the results of a petition filed in Cole County Circuit Court.

Staff relates that during the ACA period covered by this case, AmerenUE had firm transportation contracts with Missouri Pipeline Company and Missouri Gas Company.<sup>1</sup> These transportation contracts are the subject of pending litigation in which AmerenUE has filed a petition in Cole County Circuit Court against MPC and MGC (n/k/a as MoGas) to recover an overpayment. Staff recommends the Commission allow GR-2008-0366 to remain open pending AmerenUE's pursuit of refunds in circuit court.

The Commission finds that it is reasonable to allow File No. GR-2008-0366 to remain open while Staff monitors AmerenUE's circuit court case for refunds from MPC and MGC for the overpayment of gas costs for this ACA and price periods. The Commission will direct Staff to file a status report as set out below.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission's Motion to Accept Staff's Memorandum Concerning AmerenUE's Actual Cost Adjustment is granted.
2. File No. GR-2008-0366 shall remain open pending the Cole County Circuit Court's decision regarding AmerenUE's petition, Case No. 09AC-CC00398.
3. Staff shall file a status report regarding the above-mentioned court case no later than July 12, 2010, or within 30 days of a final decision in the matter, whichever is sooner.
4. This order shall become effective upon issuance.
