STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) pursuant to the Commission's March 1, 2010, Order Directing Status Reports to be filed quarterly, and states Staff had recommended this case be held open pending the resolution of the LER discovery dispute from the prior ACA cases and Laclede's actions regarding the recovery of MoGas Pipeline (f/k/a Missouri Pipeline Company) overcharges. To that end, the Staff reports status as follows:

1. Staff's 9/22/11 Staff Reply to Laclede's Response to Staff Status Report lists the specific Laclede information Staff will need for the 2011/2012 ACA review regarding the Company's baseload and swing gas supply study.
2. Laclede received a Judgment and Order from the St. Charles County Circuit Court in the amount of \$6,638,361 plus interest for MoGas overcharges.
3. On August 14, 2013, the Commission issued its *Determination on the Pleadings Respecting Issues Relating To MoGas Pipeline, L.L.C.* ordering, among other things, that the \$3,676,000 settlement payment that is to be received by Laclede from MoGas pursuant to its settlement with MoGas be included in Laclede's ACA balance and that the ACA cases remain open until any non-MoGas related issues are resolved and final ACA balances are established in each such case. That same day, the Commission issued its *Order Approving Stipulation And Agreement, Granting Waiver,*

and Approving Cost Allocation Manual (Order) in Case No. GC-2011-0098 which provided for a settlement of the Laclede Energy Resources affiliate transaction issues in this and other ACA cases.

WHEREFORE, for the reasons stated above, Staff recommends this case be held open until Laclede demonstrates and Staff confirms in a filing with the Commission that Laclede received its MoGas settlement payment and returned those funds to their customers through its PGA/ACA mechanism.
