STAFF'S RESPONSE TO ATMOS RESPONSE TO STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), and files its Response to Atmos Energy Corporation's ("Atmos" or "Company") Response to Staff's Recommendation in this Actual Cost Accounting Case. In response Staff states:

1. On December 21, 2011, Staff filed its 2009-2010 ACA recommendation in this case.

2. On January 4, 2012, the Missouri Public Service Commission ("Commission") issued its Order directing Atmos to respond to Staff's Recommendation by January 23, 2012.

3. In compliance with the Commission's Order, on January 23, 2012, Atmos Energy Corporation filed its response to the Staff's Recommendation.

4. In this Response, Staff replies to the Company's response in the Reliability Analysis and Gas Supply Planning section and provides a revised ACA table for the 2009-2010 ACA recommendation.

5. Staff has reviewed the Company's Amended Response regarding Reliability Analysis and Gas Supply. The Company's response commented on two issues: (1) Supply For Combined Hannibal, Canton, Palmyra and Bowling Green Service Areas, and (2) Storage Balance for Piedmont/Arcadia (MRT system). There were no recommended financial adjustments related to these two issues.

6. Neither the Staff, nor the Company, is asking the Commission to take action regarding these issues.
