ORDER APPROVING TARIFF SHEETS IN COMPLIANCE
WITH COMMISSION'S ORDER

Issue Date: July 26, 2007

Effective Date: August 1, 2007

On July 19, 2007, the Commission issued its order approving the Unanimous Stipulation and Agreement of the parties in this matter. The Commission rejected the original tariff filed by Laclede Gas Company and authorized Laclede to file new tariff sheets in compliance with the agreement. The Commission noted in its order that one of the provisions of the agreement is that rates would be implemented by August 1, 2007. The Commission found good cause to approve tariffs in compliance with the order on less than 30-days notice without the need for a motion requesting expedited treatment.

Laclede filed revised tariff sheets, Tariff No. YG-2008-0050, on July 20, 2007. The tariff sheets bear an effective date of August 20, 2007. Laclede also filed a request that the revised tariff sheets become effective on August 1, 2007.

The Commission set an expedited deadline of July 25, 2007, for parties to file responses or objections to Laclede's proposed tariff sheets. No responses were filed.

On July 24, 2007, the Commission's Staff filed its recommendation concerning Laclede's tariff sheets. Staff has reviewed Laclede's tariff filing and determined that it complies with the Commission's order and the Unanimous Stipulation and Agreement.

Staff recommends that the Commission approve the tariff sheets to become effective on and after August 1, 2007.

The Commission has reviewed Laclede's tariff sheets and the Staff's verified recommendation, which are hereby admitted into evidence. The Commission concludes that the submitted compliance tariff is consistent with the Unanimous Stipulation and Agreement and with the Commission's order approving that agreement, and shall therefore be approved. Because one provision of the agreement is that rates would be implemented by August 1, 2007, the Commission previously determined that good cause exists pursuant to Section 393.140(11), RSMo 2000, to approve the tariffs on less than 30-days notice. The Commission shall approve Laclede's revised tariff to become effective August 1, 2007.

IT IS ORDERED THAT:

1. The tariff sheets filed by Laclede Gas Company on July 20, 2007, in Tariff File No. YG-2008-0050, are approved to become effective on August 1, 2007. The tariff sheets approved are:
