**STATUS REPORT CONCERNING PROGRESS OF**

**A PETITION FILED IN COLE COUNTY CIRCUIT COURT**

COMES NOW the Staff of the Commission in the above-captioned matter and submits its Status Report concerning AmerenUE's 2007-2008 Actual Cost Adjustment (ACA) filing. Staff continues to recommend the Commission leave this case open as AmerenUE pursues of overpayment for transportation of natural gas to Missouri Pipeline Company (MPC) and Missouri Gas Company (MGC). In support, Staff states:

1. In its recommendation in this case, Staff recommended this case remain open pending resolution of 09-AC-CC00398 in which AmerenUE is pursuing refunds of overpayments made to MPC and MGC (k/n/a MoGas Pipeline) for transportation of natural gas.
2. This Circuit Court case remains pending, as can be seen through case.net, the Missouri Courts electronic system of docket information.
3. Staff will continue to monitor the status of this case.
4. Staff will report on this case and discuss any further recommendations in this or future AmerenUE ACA cases in its annual prudence reviews.

5. If there is activity in the Circuit Court case, Staff will inform the Commission of any decisions or outcomes and, if Staff has further recommendations as a result of Circuit Court activity, Staff will inform the Commission.

WHEREFORE Staff recommends the Commission order this case remain open pending AmerenUE's pursuit of refunds from MPC and MGC in the case filed in Cole County Circuit Court.
