## ORDER APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION REPORT AND ORDER

Issue Date: February 24, 2010 Effective Date: February 28, 2010

On April 2, 2009, Missouri Gas Energy, a division of Southern Union Company, submitted to the Commission proposed tariff sheets intended to implement a general rate increase for natural gas service provided in its Missouri service area. The Commission suspended those tariff sheets until February 28, 2010. The Commission issued a Report and Order on February 10, 2010, in which it rejected MGE's tariffs, but allowed MGE to file tariffs that comport with the Report and Order.

On February 16, 2010, MGE filed tariff sheets which the Commission denominated Tariff No. YG-2010-0500. MGE filed certain substitute tariff sheets on February 22, 2010. MGE stated that these tariffs comply with the Commission's February 10, 2010 Report and Order. The tariffs bear an effective date of March 18, 2010, but MGE requests that the tariffs become effective for service on and after February 28, 2010. MGE argues that for every day beyond February 28, 2010 that tariffs implementing the Commission's Report and Order are not in effect, MGE stands to lose over \$40,000 that the Commission has already determined MGE is entitled to recover.

The Commission ordered its Staff to file a Recommendation no later than February 22, 2010, and allowed other parties until February 22, 2010 to object to MGE's tariff filing. On February 22, 2010, after MGE filed its substitute tariff sheets, Staff filed a Recommendation that stated that the tariff sheets comply with the Commission's Report and Order, and recommended that the Commission approve them. Staff also stated that the Commission's Report and Order states good cause for the Commission to approve the tariffs on less than 30 days' notice.

The Office of the Public Counsel objected to MGE's tariff on February 22, 2010. OPC does not object to the substance of the tariffs, but objects to the tariffs for the same reasons that it seeks rehearing. OPC's Application for Rehearing remains pending. No other parties object to MGE's tariff filing.

The Commission reviewed the tariff filings, the Staff Recommendation, and OPC's objection, and determines that the filings comply with the Commission's order. The Commission further finds that good cause exists for MGE to be excused from Section 393.140(11)'s requirement that tariffs have a 30-day effective date.

## THE COMMISSION ORDERS THAT:

- 1. The Motion for Expedited Treatment filed by Missouri Gas Energy, a division of Southern Union Company, is granted.
- 2. The following tariff sheets in Tariff Nos. YG-2010-0500, issued February 16, 2010, as substituted on February 22, 2010, are hereby approved to become effective on February 28, 2010:
