After Staff had filed its recommendation on December 18, 2013, Empire transmitted documentation received by Staff on January 24, 2014, allowing the Staff to determine that the Southern Star reservation charges of \$20,099 were in fact recovered only once. - 3. Therefore, based on new information from the company, the Staff has withdrawn its adjustment on this issue and has removed the adjustment in the updated ACA table provided in the attached Memorandum. As a result, there are no other issues that require the Commission's attention.

WHEREFORE, based on the reasons stated above and in Staff's Memorandum, the Staff recommends the Commission establish Empire's 2011-2012 ACA balances according to the updated table in Staff's Memorandum and close this case.

The Procurement Analysis Unit ("Staff") of the Missouri Public Service Commission filed its 2011-2012 ACA recommendation on December 18, 2013. On January 9, 2014, the Commission issued its Order directing the company to respond to Staff's Recommendation by February 3, 2014. On January 29, 2014, Empire District Gas Company ("Empire" or "Company") filed its response to Staff's Recommendation. In this memorandum, Staff replies to the Company's response.

SOUTHERN STAR RESERVATION CHARGES

For the month of September 2011, the Company disputed Staff's claim that Southern Star reservation charges totaling \$20,099 were recovered twice, asserting that these charges were included only once, as fixed demand charges. After the Staff reviewed documentation received from the Company on January 24, 2014 (and after the Staff had filed its Recommendation on December 18, 2013), Staff determined that the Southern Star reservation charges of \$20,099 were recovered only once. Therefore, based on additional documentation received from the Company, the Staff will withdraw its adjustment on this issue. See the updated ACA table in this memorandum which removes the disputed amount of \$20,099.

The Company is in agreement with the remaining compliance adjustments.

The Company also commented on the Reliability Analysis and Gas Supply Planning section and Hedging section. In those sections, the Company's response is acceptable to Staff.

V. RECOMMENDATIONS

The Staff recommends that the Commission issue an order requiring Empire to:

1. Adjust the balances in its 2011/2012 ACA filing to reflect the ending (over)/under recovery balances for the ACA, TOP, TC, and Refund accounts per the following **updated** table:
