ORDER DETERMINING TEST YEAR, UPDATE, AND TRUE-UP

Effective Date: January 23, 2014

The Missouri Public Service Commission is determining the time periods relevant to the proposed tariff sheets (“tariff”) as follows.

Test year	12 months ending on September 30, 2013
Update	through December 31, 2013
True-up	through June 30, 2014, with data available on July 18, 2014

Data from those periods will best prove or disprove the propriety of the tariff.

Summit Natural Gas of Missouri Inc. (“Summit”) filed the tariff¹ based on data from a 12-month period (“test year”),² and proposed updates (“known and measurable changes”) to that data.³ Staff filed a response setting forth the agreements of Summit and Staff, including further significant data (“true-up”).⁴ The Commission received no other response within the time provided.⁵

The tariff must provide for safe and adequate service⁶ at just and reasonable rates.⁷ The Commission concludes that data from the periods agreed by Summit and Staff is the most persuasive under that standard. Therefore, the Commission will order those periods.

THE COMMISSION ORDERS THAT:

1. The time periods relevant to the propriety of the pending tariff sheets shall be those set forth in the body of this order.
2. This order shall become effective immediately on issuance.
