## ORDER APPROVING STIPULATION AND AGREEMENT AND ESTABLISHING ACA BALANCE

Issue Date: April 6, 2017 Effective Date: April 16, 2017

The Staff of the Missouri Public Service Commission filed a recommendation on the Actual Cost Adjustment ("ACA") for Summit Natural Gas of Missouri, Inc.'s (hereinafter, "Summit" or the "Company") 2014-2015 ACA filing. In addition to dollar adjustments, Staff also identified issues of concern. Summit filed a response to Staff's recommendation. On February 22, 2017, Summit and Staff submitted a Stipulation and Agreement ("Agreement") that will resolve all outstanding issues.

Under the terms of the Agreement, Summit agrees to adjust its ACA account balances for its service territories to reflect adjustments and ending balances as follows:

  - 4. This order shall become effective on April 16, 2017.
  - 5. This file shall close on April 17, 2017.
