## ORDER ADOPTING STAFF RECOMMENDATIONS AND ESTABLISHING ACA BALANCE

Issue Date: February 15, 2012 Effective Date: February 28, 2012

The Commission opened this case to receive the 2009-2010 Actual Cost Adjustment (ACA) filing of Southern Union Company, d/b/a Missouri Gas Energy (MGE). On December 28, 2011, the Staff of the Commission filed a recommendation and memorandum indicating Staff has completed an analysis and evaluation of billed revenues and actual gas costs for the period July 1, 2009, through June 30, 2010, included in MGE's computation of its ACA account balances. Staff also conducted a reliability analysis; a review of the company's rationale for its reserve margin for peak cold day; a review of normal, warm, and cold weather gas supply requirements, and a review of the company's hedging plans.

Staff recommend that the Commission increase MGE's ACA account balance by \$66,399.64 to correct an error made by the company. Staff further recommended that MGE respond to Staff's concerns about capacity and supply planning and about its hedging practices.

On January 3, 2012, the Commission directed MGE to respond to Staff's recommendations by February 2. MGE filed its response on February 2, indicating it accepts Staff's proposed adjustment. MGE also indicates its willingness to discuss and resolve Staff's other concerns.

After reviewing Staff's recommendations and MGE's response, the Commission concludes that MGE should adjust its ACA balance as recommended by Staff.

## THE COMMISSION ORDERS THAT:

1. Southern Union Company, d/b/a Missouri Gas Energy shall establish the following ACA account balance in its next ACA filing to reflect the June 30, 2010 (over)/under-recovered ACA balance:
