## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: September 2, 2021

Effective Date: September 2, 2021

On September 1, 2021,<sup>1</sup> Spire Missouri Inc.<sup>2</sup> d/b/a Spire Missouri East and Spire Missouri West filed an Application to Update its Weather Normalization Adjustment Rider (WNAR) per sheets in Tariff Tracking Numbers JG-2022-0047 and JG-2022-0048. Spire Missouri states that the Weather Normalization Adjustment (“WNA”) for Spire East is \$0.00381 per therm and the WNA for Spire West is \$0.00820 per Ccf of gas used. Spire Missouri states that for the average Spire East residential customer, the charge is 26 cents per month, and for the average Spire West residential customer the charge is 51 cents per month. Spire Missouri states that while the new rates are a reduction from the previous WNAR rates, the actual amount on a customer’s bill will vary depending upon customer usage.

The tariff sheets filed under JG-2022-0047 and JG-2022-0048 bear an October 1, 2021, effective date. The Commission will direct the Staff of the Commission to file a recommendation, and will establish a deadline for any other entity to file a response to the proposed tariff changes.

1. No later than September 10, 2021, the Staff of the Commission shall file a recommendation regarding Tariff Tracking Nos. JG-2021-0051 and JG-2021- 0052.
2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so no later than September 13, 2021.
3. This order shall be effective when issued.
