On May 24, 2022, Spire Missouri, Inc. submitted a draft Cost Allocation Manual (CAM) along with a motion asking the Commission to approve that CAM.¹ The Commission will provide notice of Spire Missouri's application, establish a time to apply to intervene, and a time to respond to the draft CAM.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to each party in Spire Missouri's current general rate case, File No. GR-2022-0179.
2. Applications to intervene shall be filed no later than June 14, 2022.
3. Anyone wishing to respond to the draft CAM submitted by Spire Missouri shall do so no later than June 21, 2022.
4. This order shall be effective when issued.
