**ORDER DIRECTING FILING**

On December 27, 2022, Spire Missouri Inc., (Spire) filed an application and petition with the Commission pursuant to Sections 393.1009, 393.1012, and 393.1015, RSMo, and Commission Rules 20 CSR 4240-2.060, 2.080, and 3.265. Spire asked that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges (ISRS).

On April 20, 2023, the Commission approved ISRS charges different from those listed in the tariff accompanying the application (Order). On April 21, 2023, Spire filed the above-referenced tariff to comply with the Commission’s Order.

The compliance tariff contains an effective date of May 20, 2023. However, in a Motion for Expedited Treatment, Spire asks that the Commission approve the tariff to become effective on May 1, 2023.

The Commission will order responses.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Staff shall file a Recommendation or alternative pleading no later than April 25, 2023.

2. Any other responses shall be filed no later than April 25, 2023.
3. This order is effective when issued.
