**RESPONSE OF GREAT PLAINS ENERGY INCORPORATED AND

TO THE ORDER DIRECTING APPLICANTS TO PROVIDE INFORMATION**

Pursuant to the Order Directing Applicants to Provide Information issued by the Missouri Public Service Commission ("Commission") on April 8, 2008 in the above-captioned proceeding, Great Plains Energy Incorporated ("Great Plains Energy") and Kansas City Power & Light Company ("KCPL") hereby report their compliance with that order.

In support hereof Great Plains Energy and KCPL state as follows:

1. On April 8, 2008, the Commission issued an order that included the following directive:

No later than April 11, 2008, Great Plains Energy Incorporated and Kansas City Power & Light Company shall produce copies of the rating agency letters without information redacted. Production of these documents shall be made to the requesting parties and any other party as required under the discovery procedures set out in this case.

2. Great Plains Energy and KCPL hereby report that on March 28, 2008, counsel for Great Plains Energy and KCPL provided such unredacted copies via e-mail to counsel for Staff, the Office of Public Counsel, and Praxair, Inc., AG Processing, Inc., and the Sedalia Industrial Energy Users' Association. To the best of Great Plains Energy's and KCPL's knowledge and belief, no other party has requested those documents. Consequently, Great Plains Energy and KCPL have fully complied with the above-quoted directive.
