8 **Q. Please state your name and business address.**

14 **Q. What is the purpose of your supplemental direct testimony in this**
15 **proceeding?**

16 A. The purpose of my supplemental direct testimony in this proceeding is to
17 provide a calculation of rates designed to recover as near as practicable the proposed
18 supplemental class revenue requirements contained in the updated class cost of service
19 study described in the supplemental direct testimony of Company witness Difani.

20 **Q. Mr. Warwick, how were the charges within each rate schedule**
21 **adjusted to recover the proposed supplemental class revenue requirements?**

Direct Testimony of
William M. Warwick

1 A. The class Customer Charges were changed to levels which are closer to
2 the full recovery of customer-related costs as quantified in the supplemental direct
3 testimony of Mr. Difani. The resulting class revenues provided by the proposed
4 Customer Charges were subtracted from Mr. Difani's total revenue requirements for
5 each customer class. The remaining revenue requirement of each class was then
6 recovered through the volumetric Delivery Charges while maintaining the existing rate
7 design. The resulting rates are illustrated in the attached supplemental direct Schedule
8 6.

9 **Q. Does this conclude your testimony?**

10 A. Yes.
