On October 17, 2000, the Commission issued its Order Approving Unanimous Stipulation and Agreement (Order) in Case No. GR-2000-512. This Order approved an increase in overall Missouri jurisdictional gross annual gas revenues of \$4.2 million.

Union Electric Company d/b/a AmerenUE (AmerenUE or Company) filed tariff sheets on October 23, 2000 to comply with the Order.

In its letter of transmittal accompanying the October 23, 2000 compliance filing, AmerenUE stated effective date of November 1, 2000, which would be less than the standard 30 day period, complies "with the Order, which authorizes the November 1, 2000 tariff effective date. AmerenUE is excused under rule 4 CSR 240-2.065(2) from filing a Motion for Expedited Treatment." This date would coincide with the effective date of AmerenUE's Scheduled Winter Season PGA Filing, File No. 200100446.

The Commission's Gas Department - Tariffs/Rate Design Staff (Staff) has reviewed the tariff sheets as filed by AmerenUE on October 23, 2000 and is of the opinion that these sheets are in compliance with the Commission's Order. Staff is of the opinion that good cause for approval of these tariff sheets on less that thirty days notice is demonstrated by the Commission's Order. Therefore, Staff recommends the following tariff sheets filed on October 23, 2000 be approved:
