On September 21, 2020, The Empire District Gas Company d/b/a Liberty filed the above-referenced application. Liberty seeks permission and approval and a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Platte County, Missouri, as a further expansion of its existing certificated area.

The Commission directed notice of the application, and set a deadline for interested parties to intervene. The Commission received no intervention requests. Thus, the Commission will now order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission’s Staff shall file a Recommendation no later than November 10, 2022.
2. This order shall be effective when issued.
