- 1. On May 24, 2023, The Empire District Gas Company d/b/a Liberty ("EDG") filed a tariff sheet in Tariff Tracking No. YG-2023-0209 that EDG stated in its accompanying cover letter were being submitted pursuant to the Stipulation and Agreement (Stipulation) that was filed on May 10, 2023, and the updated maps submitted therein on May 23, 2023.
