## **ORDER DENYING MOTION TO REJECT**

The Missouri Public Service Commission is denying the Office of Public Counsel's ("OPC") motion to reject.<sup>1</sup>

The motion to reject is among the many filings related to the pending motions for summary determination of Staff and Southern Union Company ("the utility"). The utility's motion for summary determination is the subject of Staff's suggestions in opposition ("Staff's suggestions").<sup>2</sup> Staff's suggestions prompted the utility's reply suggestions.<sup>3</sup>

The utility's reply suggestions are the target of OPC's motion to reject. The utility filed a response.<sup>4</sup> OPC filed a reply.<sup>5</sup>

OPC argues that the utility's reply suggestions are too late in responding to Staff's suggestions under the 10-day regulatory deadline for filing a response to a

pleading.<sup>6</sup> A "pleading," the utility argues, does not include the utility's reply suggestions:

Pleading means any application, complaint, petition, answer, motion, staff recommendation, or other similar written document, which is not a tariff or correspondence, and which is filed in a case. A brief is not a pleading under this definition.  $[^7]$ 

The utility's reading is either correct, or close enough to constitute the excusable

neglect that excuses late filing, under the Commission's regulation.<sup>8</sup>

Therefore, the Commission will deny OPC's motion to reject.

## THE COMMISSION ORDERS THAT:

- 1. Public Counsel's Motion to Reject Filing is denied.
- 2. This order shall become effective immediately upon issuance.
