ORDER ESTABLISHING ENDING ACA BALANCES

Issue Date: January 15, 2014 Effective Date: January 25, 2014

The Commission opened this case to receive the 2011-2012 Actual Cost Adjustment (ACA) filing of Union Electric Company, d/b/a Ameren Missouri. On October 30, 2013, the Staff of the Public Service Commission filed a recommendation and memorandum indicating that Staff has completed an audit of billed revenues and actual gas costs for the period September 1, 2011 through August 31, 2012, included in Ameren Missouri's computation of its ACA balances.

Staff set out the ending balances contained in Ameren Missouri's ACA filing and recommended adjustments to those ending balances. Staff also offered some non-financial recommendations regarding Ameren Missouri's policies and practices. Ameren Missouri responded to Staff's recommendations on December 2, 2013, indicating its acceptance of Staff's financial adjustments. Ameren Missouri also responded to Staff's non-financial recommendations. On January 6, 2014, Staff replied to Ameren Missouri's response. Staff says there are no issues that require Commission resolution and advises the Commission to establish the ending ACA balances indicated in Staff's October 30, 2013 recommendation.

After reviewing Staff's recommendations and Ameren Missouri's response, the Commission concludes that Staff's ending ACA balances should be accepted as a resolution of Ameren Missouri's 2011-2012 ACA audit. Because Staff's balances are unopposed, the Commission will give this order a ten-day effective date.

THE COMMISSION ORDERS THAT:

1. The ending (over)/under recovery balances for Union Electric Company, d/b/a Ameren Missouri's 2011-2012 Actual Cost Adjustment are established as provided in the following table:
