**ORDER APPROVING TARIFFS IN COMPLIANCE
WITH COMMISSION REPORT AND ORDER**

Issue Date: December 22, 2014

Effective Date: January 4, 2015

On February 6, 2014, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities, submitted to the Commission proposed tariff sheets intended to implement a general rate increase for natural gas service provided in its Missouri service area. The Commission suspended those tariff sheets until January 4, 2015.

The Commission issued a Report and Order on December 3. That Report and Order rejected Liberty Utilities' tariffs. But it also allowed Liberty Utilities to file tariffs that comport with the Report and Order.

On December 5, Liberty Utilities filed tariff sheets which the Commission denominated Tariff No. YG-2015-0216. Liberty Utilities filed certain substitute tariff sheets on December 10 and December 11. Liberty Utilities stated that these tariffs comply with the Commission's Report and Order. The tariffs bear an effective date of January 4, 2015.

The Commission ordered its Staff to file a Recommendation no later than December 15, and allowed other parties until December 16 to object to Liberty Utilities' tariff

filing. Staff filed a Recommendation on December 15, 2014. The Recommendation stated that the tariff sheets comply with the Commission's Report and Order, and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff's Recommendation.

The Commission reviewed the tariff filings and Staff's Recommendation, and determines that the filings comply with the Commission's order.

THE COMMISSION ORDERS THAT:
