On May 27, 2016, Missouri Gas Energy (MGE), an operating unit of Laclede Gas Company, filed *Missouri Gas Energy's Response to Order Directing Filing of Status Report and Request for Waiver/Variance*.

On June 2, 2016, the Staff of the Commission filed a *Staff Request for Extension of Time in Which to Respond to Missouri Gas Energy's Response to Order*. Commission rule 4 CSR 240-2.080(13) allows ten days from the date a pleading is filed for other parties to submit a response. Staff seeks an additional ten days to respond to MGE's filing. Staff explains that due to scheduling conflicts and the press of other business it needs additional time. Staff represents that no party will be harmed by granting the extension.

The Commission finds Staff's request reasonable, and will grant it.

1. Staff may respond to MGE's filing no later than June 16, 2016.
