## ORDER DIRECTING STAFF TO REPLY

On December 5, 2017, the Staff of the Commission filed a recommendation and memorandum indicating Staff has reviewed the 2015-2016 Actual Cost Adjustment (ACA) filing of Union Electric Company d/b/a Ameren Missouri. Staff did not propose financial adjustments to Ameren Missouri's ACA balances, but offered non-financial recommendations regarding the company's policies. The Commission directed Ameren Missouri to respond to Staff's recommendations, and the company did so on January 5, 2018.

Before acting to resolve Ameren Missouri's actual cost adjustment filing, the Commission will direct Staff to indicate whether it is satisfied with Ameren Missouri's response and whether it is now appropriate for the Commission to establish the final balances for Ameren Missouri's 2015-2016 ACA.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall reply to Union Electric Company d/b/a Ameren Missouri's Response to Staff Recommendation no later than January 19, 2018.

2. This order shall be effective when issued.
