On October 19, 2016, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities ("Liberty Utilities") filed a tariff sheet proposed to become effective November 3, 2016. The tariff sheet reflects changes in Liberty Utilities' Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas for the upcoming winter season.

The Commission will order its Staff to file a Recommendation.

1. The Staff of the Commission shall file its recommendation regarding the above-referenced tariff sheet no later than October 31, 2016.


