

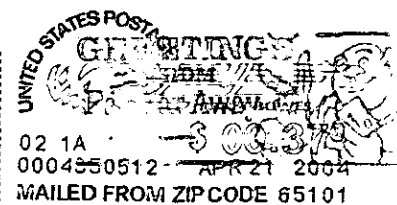

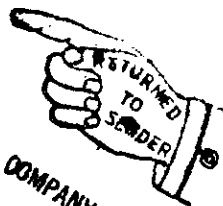
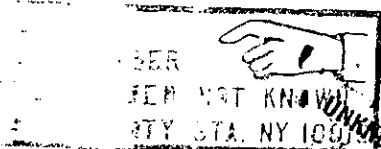

ORDER GRANTING LEAVE TO APPEAR

ORDER GRANTING LEAVE TO FILE AMENDED DIRECT TESTIMONY

On April 21, 2004, the Staff of the Commission filed a motion requesting leave to file the amended direct testimony of Paul R. Harrison. Staff filed Mr. Harrison's direct testimony on April 15, and since has discovered two errors in that testimony. Specifically, Mr. Harrison twice refers to attached schedules that are, in fact, not attached to his testimony. Along with its motion, Staff filed an amended version of the testimony that removes the references to non-existent schedules.

The corrections that Staff has made to Mr. Harrison's testimony do not change the substance of that testimony and will not prejudice any other party. Correcting the mistakes will, rather, avoid the confusion that could result as readers search for non-existent schedules. Staff's motion will be granted.

IT IS THEREFORE ORDERED:

1. That Staff's Motion for Leave to File Amended Direct Testimony is granted.

2. That this order shall become effective on April 22, 2004.


