STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

- 1. On March 29, 2007, Northeast Missouri Rural Telephone Company filed an application with the Commission for an accounting authority order to book depreciation rates on new equipment in excess of depreciation rates currently allowed for ratemaking purposes.
- 2. Section 392.280.2 RSMo provides that a telecommunications company may request the Commission to authorize minimum depreciation rates in lieu of fixed rates, and to record depreciation expense on the basis of depreciation rates in excess of such minimum rates.
- 3. In Case No. TA-2002-61, the Commission set minimum depreciation rates for Northeast and authorized it to record depreciation expense on the basis of depreciation rates in excess of such minimum rates. Specifically, as relevant to the current case, the Commission set a minimum depreciation rate of 10.00% for Account 2232, Digital Circuit Equipment, and authorized Northeast to book depreciation expense based on a higher depreciation rate of 10.30%.
- 4. In the current case, Northeast requests authorization to record depreciation expense for Account 2232 at 20.00%, while maintaining the minimum depreciation rate of 10.00%. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Commission approve Northeast's request.

WHEREFORE, the Staff recommends the Commission authorize Northeast to record depreciation expense for Account 2232 using a depreciation rate of 20.00%, effective July 1, 2007.

Staff recommends that the Commission authorize the Company to book a higher depreciation rate of 20.00% for Account 2232, Digital Circuit Equipment, and to record depreciation expense on the basis of this depreciation rate, in excess of the minimum 10% depreciation rate established in Case No. TA-2002-0061. In Case No. TA-2002-0061 the Commission authorized minimum depreciation rates in lieu of fixed rates for the Company and, specific to this account, authorized the Company to book a higher depreciation rate of 10.30% and to record depreciation expense based on the 10.30% depreciation rate. A 10% fixed rate for this account was ordered in Case No. TR-2001-0344.

Staff concurs with the Company that it may request the Commission to authorize minimum depreciation rates in lieu of fixed rates, and to record depreciation expense on the basis of depreciation rates in excess of such minimum rates as provided in Missouri Revised Statutes, Chapter 392, Section 392.280.
