On July 18, 2006, Aquila, Inc., d/b/a Aquila Networks-L&P, filed a steam service tariff sheet providing the current Quarterly Cost Adjustment for service provided to steam customers in the company's L&P service territory. The tariff sheet bears an effective date of September 1, 2006.

The Commission finds that notice of the tariff filing shall be given to the parties to Aquila Networks-L&P's most recent steam rate case. The Commission will also set dates for the filing of the Staff's recommendation and for any responses to Staff's recommendation.
