ORDER APPROVING TARIFF SHEET FILED IN COMPLIANCE
WITH COMMISSION’S ORDER

Issue Date: May 24, 2007

Effective Date: June 1, 2007

On April 16, 2007, Aquila, Inc., d/b/a Aquila Networks–L&P, submitted a proposed tariff sheet that contains a quarterly cost adjustment to allow customer rates to change with fuel cost changes. The tariff sheet was filed pursuant to the terms of the Stipulation and Agreement approved by the Commission in Case No. HR-2005-0450. Aquila’s tariff sheet, which has been designated as Tariff No. JH-2007-0742, has a proposed effective date of June 1, 2007.

On May 17, 2007, the Staff of the Missouri Public Service Commission filed a recommendation. Staff states that it has reviewed Tariff No. JH-2007-0742 and is of the opinion that it complies with the Commission’s order in Case No. HR-2005-0450. Staff recommends that the Commission approve the proposed tariff sheet to become effective on June 1, 2007. No objections to the tariff were filed.

The Commission has reviewed Aquila’s tariff sheet and Staff’s verified recommendation, which is hereby admitted into evidence. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Commission’s previous order and shall be approved as ordered below.

In addition, because this type of tariff filing is expected to be made on a quarterly basis, the Commission shall leave this case open to receive the remaining quarterly filings for the current twelve-month period. After a twelve-month period has passed, the Commission shall require Aquila to make the following quarterly filing in a new case.

IT IS ORDERED THAT:

1. Tariff No. JH-2007-0742, submitted on April 16, 2007, is hereby approved for steam service rendered on or after June 1, 2007. The tariff sheet approved is:
