STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, for its recommendation to approve tariff sheet, respectfully states:

1. In the attached Memorandum (Appendix A) the Staff recommends the Missouri Public Service Commission (Commission) approve the tariff sheet Aquila filed on April 15, 2008, to become effective June 1, 2008. Aquila filed the tariff sheet to make a quarterly cost adjustment required as part of the Stipulation and Agreement approved by the Commission in Case No. HR-2005-0450. That Stipulation and Agreement includes a "fuel rider" that requires quarterly rate adjustments, with not more frequent than annual true-ups.

2. Staff has reviewed the tariff sheet and, based on Aquila's accompanying workpapers, is of the opinion that the quarterly cost adjustment for the 2008 First Quarter (Q1) has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider tariff sheet and complies with the Commission's Order in HR-2005-0450.

3. The Staff recommends the Commission issue an order approving the proposed tariff sheet to be effective June 1, 2008, or allow the sheet to go into effect by operation of law.

WHEREFORE, the Staff of the Missouri Public Service Commission recommends the Commission either approve to become effective June 1, 2008 or allow to go into effect by operation of law on June 1, 2008, the Tariff Sheet Aquila, Inc. d/b/a Aquila Networks-L&P filed on April 15, 2008, to wit:

On April 15, 2008, Aquila, Inc. d/b/a Aquila Networks – L&P (Aquila or Company) of Kansas City, Missouri, filed with the Commission one (1) tariff sheet with an issue date of April 15, 2008, and a proposed effective date of June 1, 2008, to add the quarterly cost adjustment for the first quarter of 2008 as required by Company's Quarterly Cost Adjustment Rider, which the Commission approved in Case No. HR-2005-0450.

The Commission assigned Case No. HR-2007-0028 for the filings during the initial audit period (Q206 – Q406) and any subsequent prudence review and true-up of the revenues collected during that audit period. The Commission assigned Case No. HR-2007-0399 for the second audit period (Q107 – Q407). The Commission assigned Case No. HR-2008-0340 for the third audit period (Q108 – Q408). Aquila's filing included workpapers consisting of four worksheets showing its calculation of the quarterly cost adjustment for the first quarter of 2008.

The Commission's Energy Department Staff (Staff) has reviewed the proposed tariff sheet, and based on the Company's workpapers Staff is of the opinion that the quarterly cost adjustment for the first quarter of 2008 (Q108) has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider. Staff therefore recommends that the Commission approve the following proposed tariff sheet, as filed on April 15, 2008, to become effective on June 1, 2008, as requested by Aquila, or permit the tariff sheet to go into effect by operation-of-law:
