STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and, for its recommendation to approve tariff sheet, respectfully states:

- 1. In the attached Memorandum (Appendix A) the Staff recommends the Commission approve the tariff sheet KCP&L Greater Missouri Operations Company (GMO) filed on October 14, 2010, to become effective December 1, 2010.
- 2. On October 14, 2010, GMO filed its tariff sheet to make a quarterly cost adjustment required as part of the Stipulation and Agreement approved by the Commission in Case No. HR-2009-0092.¹ That Stipulation and Agreement includes a "fuel rider" that requires quarterly rate adjustments, with not more frequent than annual true-ups.
- 3. Staff reviewed the tariff sheet, and is of the opinion that the quarterly cost adjustment for the third quarter of 2010 has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider tariff sheet and complies with the Commission's Order in HR-2009-0092.
- 4. The Staff recommends the Commission issue an order approving the tariff sheet to become effective December 1, 2010, as requested by GMO, or allow it to go into effect by operation of law.

¹ The adjustment is required by GMO's Quarterly Cost Adjustment Rider, which the Commission approved in Case No. HR-2005-0450, and modified in Case Nos. HR-2009-0092 and HR-2010-0028, for steam service on and after July 1, 2009.

WHEREFORE, the Staff of the Missouri Public Service Commission recommends the Commission approve to become effective December 1, 2010, or allow to go into effect by operation of law, the Tariff Sheet GMO filed on October 14, 2010, to wit:
