**KCP&L GREATER MISSOURI OPERATIONS COMPANY’S  
MOTION FOR APPROVAL OF COMPLIANCE TARIFF SHEETS**

COMES NOW KCP&L Greater Missouri Operations Company (“GMO”) and respectfully request that the Missouri Public Service Commission (“Commission”) approve the compliance tariff sheets filed in this docket by GMO on November 8, 2016 (“Compliance Tariffs”). In support thereof, GMO states as follows:

1. On September 20, 2016, GMO, Staff of the Missouri Public Service Commission (“Staff”), Missouri Department of Economic Development – Division of Energy (“DE”), Midwest Energy Consumers Group (“MECG”), and Missouri Industrial Energy Consumers (“MIEC”) filed their Non-Unanimous Stipulation and Agreement in this docket.

2. Also, on September 20, 2016, GMO and Staff filed their Non-Unanimous Stipulation and Agreement Regarding Pensions and Other Post-Employment Benefits in this docket.

3. On September 28, 2016, the Commission issued its *Order Approving Stipulations and Agreements, Rejecting Tariffs, Cancelling True-Up Hearing, and Ordering Filing of Compliance Tariffs* (“Order”) rejecting tariff sheets assigned Tracking Nos. YE-2016-0223 and JE-2017-0007 and directing filing of new tariff sheets no later than November 8, 2016.

4. On November 8, 2016, GMO filed Compliance Tariffs (Tariff No. YE-2017-0068) as directed by the Commission’s Order.

5. GMO requests Commission approval of the Compliance Tariffs with an effective date of December 22, 2016.

WHEREFORE, GMO respectfully request that the Commission approve the Compliance Tariffs as set forth in paragraph 4.
