**KCP&L GREATER MISSOURI OPERATIONS COMPANY'S  
MOTION FOR EXPEDITED CONSIDERATION AND APPROVAL  
OF TARIFF SHEET ON LESS THAN THIRTY DAYS' NOTICE**

COMES NOW KCP&L Greater Missouri Operations Company ("GMO" or the "Company") and hereby files its Motion for Expedited Consideration and Approval of Tariff Sheet on Less than Thirty Days' Notice ("Motion"). In support of its Motion, KCP&L states as follows:

1.       GMO filed a tariff sheet on September 30, 2016 with an effective date of December 1, 2016 for its annual Renewable Energy Standard Rate Adjustment Mechanism ("RESRAM") tariff filing, with Tracking No. JE-2017-0049 ("0049 Tariff").
2.       After discussions with Commission Staff, GMO believes that revisions are needed to the tariff sheet in order to reduce the RESRAM tariff charge. Also pursuant to discussions with Staff, GMO withdrew the 0049 Tariff on November 8, 2016.
3.       Contemporaneous with this Motion, GMO filed the substantively revised RESRAM tariff, Tracking No. YE-2017-0067 ("0067 Tariff").
4.       GMO requests that the Commission approve the tariff sheet to become effective on less than 30 days' notice, so that the tariff sheet will become effective December 1, 2016. By granting GMO's Motion, the Commission will ensure that ratepayers are charged the lower rate as soon as possible.
5.       This Motion was filed as soon as it could have been under the circumstances.

**WHEREFORE**, GMO respectfully requests that the Commission grant GMO's Motion and approve the 0067 Tariff to go into effect on less than thirty days' notice.
