**KCP&L GREATER MISSOURI OPERATIONS COMPANY’S
MOTION TO CHANGE HEARING DATES**

NOW COMES KCP&L Greater Missouri Operations Company (“GMO” or “Company”) and, for its *Motion to Change Hearing Dates* (“Motion”), states as follows:

1. On March 6, 2019, the Missouri Public Service Commission (“Commission”) issued its *Order Adopting Procedural Schedule* (“Order”) which set the hearings in this docket for July 16-17, 2019.

2. The Company recently discovered that Company witness Darrin Ives has a conflict with this hearing schedule, as Mr. Ives was inadvertently committed to two hearings (one in Topeka and the other in Jefferson City) on the same day.

3. As such, the Company requests that the Commission issue an order moving the hearing dates for this docket forward one day, to July 17-18, 2019. The current schedule calls for hearings on July 16-17, 2019.

4. Staff for the Commission (“Staff”), the Office of the Public Counsel (“OPC”), and Midwest Energy Consumers Group (“MECG”) have been made aware of the Company’s request prior to the filing of this Motion and all have indicated that they do not oppose.
