**NOTIFICATION**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) and, pursuant to the terms of the *Non-Unanimous Stipulation and Agreement (Stipulation)* filed in this case, submits the following:

1.       The *Stipulation* requires Ameren Missouri to file a notice in this case no fewer than five business days prior to making a change in its measure and/or incentive amount offering.<sup>1</sup>

2.       Ameren Missouri is modifying the residential Heating and Cooling program to increase rebates for failed central air conditioners to an amount equal to rebates for operating central air conditioners, allowing additional confidence in contractor reported classification of systems and simplifying the presentation of program rebates to customers. The information provided in the attached Heating and Cooling Incentives for Measures identified in the TRM satisfies the filing requirement detailed in the *Stipulation*.

3.       In accordance with the *Stipulation*, Ameren Missouri is providing notice of these changes, which it intends to implement as of March 1, 2018. Attached to this pleading are a copy of the revised Heating and Cooling Incentives for Measures identified in the TRM, with the changes highlighted for ease of identifying where changes occurred, as well as a clean copy of the same.
