**ORDER DIRECTING NOTICE AND SETTING INTERVENTION DATE**

On November 9, 2007, Laclede Gas Company filed a petition with the Missouri Public Service Commission requesting implementation of a new Infrastructure System Replacement Surcharge ("ISRS") rate schedule to provide recovery of costs for infrastructure system replacement and relocations eligible for ISRS recognition. Section 393.1015.2(3), RSMo Supp. 2006, requires the Commission to act on Laclede's application no later than 120 days after it was filed. Consequently, the Commission must issue a decision regarding Laclede's petition effective no later than March 8, 2008.

The Commission will give notice of this application to the public and to others who may be interested. The Commission will also set a date for the filing of intervention requests.

**IT IS ORDERED THAT:**

1. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in Laclede's service area, as well as to the corresponding governing body for the City of St. Louis. In

addition, the Data Center shall mail a copy of this notice to each party in GR-2007-0208, Laclede's last general rate case.

2. The Information Officer of the Missouri Public Service Commission shall make notice of this order available to the media serving Laclede's service area and to the members of the General Assembly representing Laclede's service area.

3. Any person wishing to intervene in this matter shall file an application to do so no later than December 3, 2007. Such application shall be filed with:
