On July 28, 2017, Laclede Gas Company filed a letter informing the Commission that it is changing the name by which it provides natural gas service in Missouri to Spire Missouri, Inc. d/b/a Spire. The company also filed tariff revisions purporting to incorporate that name change. Those tariffs carry an August 30, 2017 effective date. The Commission will direct its Staff to file a recommendation regarding that notice and tariffs.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding Laclede Gas Company's notice and tariffs no later than August 16, 2017.

2. This order shall be effective when issued.
