On September 22, 2006, Missouri Gas Energy (MGE), a division of Southern Union Company, filed a tariff sheet with the Missouri Public Service Commission (Commission) with a proposed effective date of October 22, 2006. In addition, MGE filed a Motion For Expedited Treatment (Motion) relating to this filing on the same day. The Motion requested an effective date of October 2, 2006.

This tariff sheet was filed to comply with the Commission's Order dated September 21, 2006, authorizing MGE to refile an Infrastructure System Replacement Surcharge (ISRS) sufficient to recover annual pre-tax revenue of \$3,679,127 as computed by the Commission's Energy-Tariff/Rate Design Staff (Staff).
