ORDER GRANTING STAFF'S SECOND MOTION FOR AN EXTENSION OF TIME TO FILE A RECOMMENDATION

The Commission directed its Staff (Staff) to file a recommendation about Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (Liberty Midstates) application to issue long-term unsecured debt. Staff's recommendation was originally due March 29, 2023. The Commission granted Staff's request for a 30-day extension so that Staff's recommendation would be due on April 26, 2023.

On April 24, 2023, Staff filed a second motion requesting an additional 30-day extension to file its recommendation. Staff states that no party objects to another extension. The Commission will grant Staff's motion and set a time for responses.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file its recommendation in this matter no later than May 26, 2023.
2. Any responses to Staff's recommendation or Liberty Midstates' application shall be filed no later than June 5, 2023.

3. This order is effective when issued.
